- Able to cut from 2 to 4 slabs from various stone materials and achieve varied slab thicknesses; depends with width not less than 60 mm;
- High versatility of cutting various kinds of stone shapes of varied sizes and shapes; maximum width of cutting not less than 3,5 meter, maximum height of cutting not less than 2,0 meter;
- Minimum losses of the cut materials thanks to thin kerfs; Kerfs not more than 10 mm;
- Water and electric energy consumption economy during cutting; Power engine max. 30 kW.

In case of a price indicate in a foreign currency, it will be recalculated by the Ordering Party in line with the Polish provisions concerning the goods and services tax within the scope concerning intra-Community purchases using the mean exchange rate of the National Bank of Poland from the day before the day of evaluation of the offer/ conclusion of the order.

In case of submission of several offers with the same price, the offerers shall be invited to make offer corrections – without changes to the offered prices, however, with expected additional services and benefits, e. g. warranties, servicing, training.

To facilitate efficient and quick verification of offers, three working days from the day of delivery by the Ordering Party of a motion for clarifications are assumed.
4. The Ordering Party reserves the right to cancel a part or the entirety of a tender without stating a reason, and the right to close the tender without choosing an offer. In each case of the Ordering Party utilising the described rights, the Contractors shall not be entitled to any claims against the Ordering Party, in particular claims for the conclusion of a contract or the reimbursement of costs of participation in the tender proceedings.
5. Partial offers are not allowed.
6. The offer must be valid for at least 30 days, counting from the day of expiry of the offer submission deadline.
